**Embryos.** Whenever a recipient is sold or a fresh embryo is transferred to the buyer's recipient, enter the identification of recipient in name space with other portions of transfer completed. Send the original copy of the transfer to the Association. When a frozen embryo is sold, submit the original to the Association. Each sale must be covered by a transfer.

DO NOT SIGN TRANSFERS IN BLANK, FOR YOUR OWN PROTECTION. FILL OUT TRANSFERS COMPLETELY. IF YOU SELL AN ANIMAL WITHOUT PAPERS, RETURN THE CERTIFICATE TO THE ASSOCIATION OFFICE FOR CANCELLATION.

### **IMPORTANT RULES PERTAINING TO THE TRANSFER OF REGISTERED AYRSHIRE CATTLE**

Article II.

- Section 1. Each transfer of ownership must be recorded. Each animal must have every successive change of ownership recorded upon the records of the Ayrshire Breeders' Assoc. Transfers must be made direct to the actual purchaser, and may be made only on application of the seller or his legal representative.
- Section 2. Seller's duty to file transfer. In the case of a change in ownership where the seller has been paid in full, it is the duty of the seller to file with the Ayrshire Breeders' Assoc. the necessary applications for transfer. Failure to comply with this rule is a direct violation of the By-Laws of this Assoc. The Ayrshire Breeders' Assoc. looks to the seller for all transfer fees.
- Section 5. Date of sale. The date of delivery shall be considered as the date of sale on transfer, except when stated otherwise by conditions of sale.
- Section 8. Association may deny transfer privileges to delinquent breeders. The Assoc. may, in its discretion, deny transfer privileges to any member, person, firm or corporation, who owes the Assoc. for fees, or who has been guilty of neglecting to complete registration or transfer applications for animals bred or sold by any member, person, firm or corporation.

### **IMPORTANT RULES PERTAINING TO THE TRANSFER OF REGISTERED AYRSHIRE CATTLE**

Article II.

- Section 1. Each transfer of ownership must be recorded. Each animal must have every successive change of ownership recorded upon the records of the Ayrshire Breeders' Assoc. Transfers must be made direct to the actual purchaser, and may be made only on application of the seller or his legal representative.
- Section 2. Seller's duty to file transfer. In the case of a change in ownership where the seller has been paid in full, it is the duty of the seller to file with the Ayrshire Breeders' Assoc. the necessary applications for transfer. Failure to comply with this rule is a direct violation of the By-Laws of this Assoc. The Ayrshire Breeders' Assoc. looks to the seller for all transfer fees.
- Section 5. Date of sale. The date of delivery shall be considered as the date of sale on transfer, except when stated otherwise by conditions of sale.
- Section 8. Association may deny transfer privileges to delinquent breeders. The Assoc. may, in its discretion, deny transfer privileges to any member, person, firm or corporation, who owes the Assoc. for fees, or who has been guilty of neglecting to complete registration or transfer applications for animals bred or sold by any member, person, firm or corporation.
